## Fourth Round of Budget Cuts Highlights Need for Balanced Approach

### KEY TAKEAWAY:

By the end of the current budget year, Mississippi is expecting a shortfall of \$459 million. In response to increasing shortfalls, Governor Barbour announced a fourth round of budget cuts totaling \$459 million to match the shortfall.

As a result of the cuts, elementary school class sizes are increasing and tuition is rising in Mississippi's universities. With the quality of services being compromised, a balanced approach that includes raising revenue is necessary to preserve jobs and education opportunities for Mississippi to move forward.

### Budget Cuts: Round 4

Nearly every state agency has sustained deep cuts. The table below illustrates the extent of the cuts in areas of government that provide critical jobs and services to the people of Mississippi.
